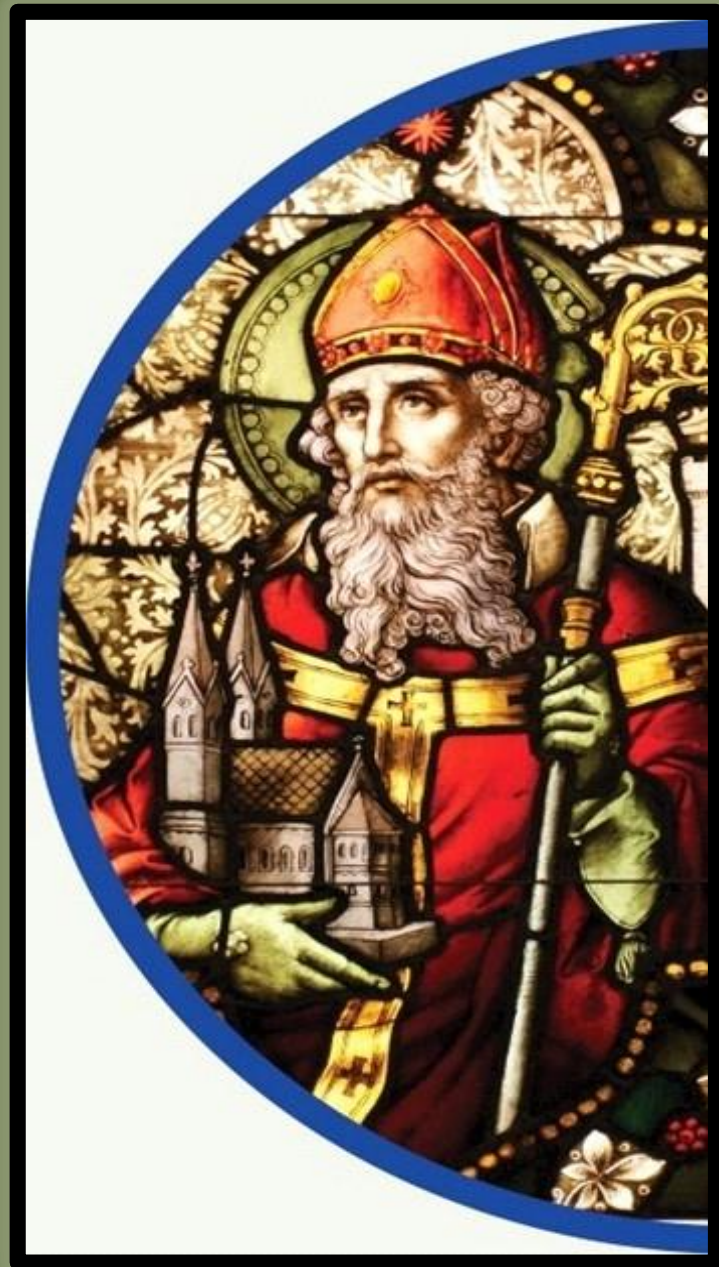
## CONGREGATION

# A BRIEF HISTORY OF THE BROTHERS OF ST. PATRICK

The Congregation of the Brothers of St. Patrick or the Patrician Brothers as they are popularly known began in the small town of Tullow, Ireland on 2nd February, 1808. The Congregation was founded by Rt. Rev. Dr. Daniel Delany, under the patronage of St. Patrick, the Patron Saint of Ireland. In 1840, the Brothers sailed across the Atlantic Ocean to Baltimore, USA and laid the foundation for their first mission abroad. In 1883, another group of Patricians arrived in Maitland, New South Wales, Australia. After establishing themselves, the brothers moved to Papua New Guinea, an island that needed the Brothers' assistance. In 1875, the first foundation of the Patrician Brothers was laid in Chennai, India. In 1901, Brothers were drawn to Kenya. In 2007, the Indian Province took up a mission in Ghana, Africa and in 2012, South Sudan and Dubai. In 2008, the Brothers completed 200 years of their existence as harbingers of education, touching and making a difference in the lives of many. Today, the Patrician Brothers run schools, colleges, boarding houses, technical institutions, nonformal education centers and other education related institutions in Ireland, United States of America, India, Australia, Papua New Guinea, Kenya and Ghana. The headquarters known as the Generalate is located at the Patrician Brothers' Monastery, Ryde, Australia, and it has its headquarters known as the Provincialate in Mount St. Mary's New Delhi.





# A BRIEF HISTORY OF ST. PATRICK'S ACADEMY, BENGALURU

Set in sylvan surroundings of evergreen trees and bushes, St. Patrick's Academy Bengaluru, situated between Ambedkar Nagar and Kodathi Gate, on Bengaluru Sarjapur fourlaned Highway, is a Bicentennial dream of the Patrician Brothers, established in 2010.

The Academy's unique Architecture and elevation instantly captures and captivates the imagination of the beholder. Teachers, students and parents are pleasantly introduced to the space, design, structure and extra - size class rooms. The school is affiliated to the I.C.S.E. board and is situated in a sprawling campus of about 15 acres of land. The Patrician Brothers and St. Patrick's Academy believe in the overall development of its pupils, hence playgrounds for every game is provided for both boys and girls.

St. Patrick's Academy is about 25 kms away from the city Railway Station and 60 kms from Bengaluru International Airport. It is just 1.5 kms away from Carmelaram Railway Station.

St. Patrick's Academy, by way of education, founded on Christian values and inspired by our Revered Founder, Bishop Daniel Delany, strives to nurture and disseminate the Patrician ethos and embraces more members into our Patrician family. The Academy's distinct impact is evident from the large number of Parents and wellwishers willing to collaborate in the educational endeavor of the Patrician Brothers. The Brothers and Staff at St. Patrick's Academy actively seek to imbibe what is best in Kannada culture and society and joyfully share our vision and experience of the kingdom of God. With the "Breastplate" (prayer of St. Patrick) as our shield, the Academy will bravely face the challenges that will pave the path, leading to growth and development.



# ACADEMICS

At the kindergarten level, it is "What I hear, I forget; What I see, I remember; What I do, I understand." Play way method is given stress to provide a strong foundation to the tiny tots. At Primary, Middle and High School, a more formal pattern is stressed upon, at the same time allocating ample room for flexibility to promote originality and creativity. While Kindergarten follows assessment system to determine the progress of the pupil, Primary, Middle and High School depends on periodical tests, Mid Terms and Term Examinations, project work etc. to assess the progress. Value Education is given paramount importance through classroom teaching, practicals, seminars, discussions, visual aids etc. St. Patrick's Academy believes that a human being is complete only when he/ she loves and appreciates others just as he/she loves himself/herself.

## THE BOARD

St. Patrick's Academy is Permanently Affiliated to CISCE (Council for the Indian School Certificate Examinations) Board, New Delhi and upgraded to ISC (Indian School Certificate) .





# LANGUAGE OPTIONS

- Second Language Kannada offered for STD I to VIII and third language Hindi.
- Second Language Kannada and Hindi are offered for STD VII and above classes.
- Apart from Second Language, there will be a Third Language (Kannada /Hindi) for Class VII and above.
- The office must be informed of any change in the student's choice of second language

Laboratories: Physics, Chemistry, Biology, Mathematics, English and Computer Science labs are well equipped for practical work

# GENERAL REGULATIONS



Parents are requested to bear in mind that the school attaches great importance to building a sound character in students. They are expected to cooperate with the school authorities by making their children understand that a well ordered and disciplined way of life is as important at home as in school. Parents should supervise their lessons, and take an active interest in school activities.

Occasional reports from teachers are made in the School Diary and parents are requested to sign them/respond to them. Regular updates are also sent online through Campus care App.

Punctuality and regularity in attendance, proper dress, an earnest effort in class and homework assignments and proper behavior in and outside school are always insisted on. Hence, hands in pockets, slouching gait, untidiness, unclean uniforms etc are considered unbecoming.

English is the medium of instruction. Hence, students are expected to speak English at all times. Students are not permitted to engage any of the school teachers for private tuition without the written permission of the Principal.

A student absent from class due to illness or owing to unforeseen circumstances must bring a letter from his/her parents/guardian explaining the reason for the absence and the same must be recorded in the school diary. Prior permission must be obtained for leave for any other reasons.

The Principal can refuse leave of absence to any student without assigning any reason.





A Doctor's certificate must be produced for sick leave exceeding 3 days.

Students absent for any examinations will be considered as failed, unless it is established that their absence was due to illness.

The school is not responsible for goods lost. Therefore, it is not advisable to bring valuable articles such as expensive watches, pens, gold ornaments, excess amount of money etc. to school. Students are strictly warned against carrying or using mobile phones in the campus. Any violation of this rule will result in the authorities confiscating the same. Carrying any material that are visual or in literature form other than that of educational need is strictly forbidden.

Students are not permitted to come into the campus on two wheelers unless they hold a valid driving/riding license.

Students who come to school in the care of anyone such as domestic workers, drivers etc are not to leave the campus on their own. In case of any delay, they should report to the school office.

Students are not expected to loiter around once the school is over. They are also cautioned against buying anything, especially eatables, from street vendors.

Maximum precaution will be taken for the safety of every child. However, the school authorities will not be responsible for any unavoidable accidents in or outside the school.

# GENERAL REGULATIONS

Parents must be strict regarding their daughters returning home from school immediately after school hours. Any problem in this connection must be reported to the Principal immediately.

Nail polish, long/dirty nails, mehendi and tattoos are not allowed. Fireworks is not allowed inside the campus in connection with any festival or celebration.

Students are permitted to stay back after school hours, only if they are involved in sports and games, extra- curricular activities or remedial classes.

Indiscipline in the school bus will not be tolerated. Such students will not be permitted to travel in the school bus.

The management reserves the right to dismiss students who fail to make satisfactory academic progress in their studies or whose conduct is in any way detrimental to the good order and discipline of the school

Students are not allowed to leave the school premises during class hours without the gate pass duly signed by the appropriate authority.

Damage to school property, however small, will not be condoned. Stringent disciplinary measures will be taken against such offenders. The parents will have to bear the expenses of the damaged property.

No student who has been convicted of any offence in a criminal court will be allowed to continue his/her studies in the school.





Students are not permitted to involve themselves in active participation in party or communal politics.

Students who indulge in political propaganda or who organize fellow students into political factions in the school premises or who otherwise engage themselves in party politics are liable to be expelled from the school.

Students should not indulge in any activity leading to the disruption of peace and discipline and dislocation of normal work in the school. Such students will be severely dealt with.

Ragging in any form is strictly forbidden. Anyone who indulges in ragging will be expelled from the school.

Students who are guilty of rude language towards the staff of the school, assault or attempt to assault the staff or fellow students of the school are liable to be expelled from the institution.

The Principal or other constituted school authorities may frame and issue from time to time disciplinary rules of a permanent or temporary character regulating the conduct in and outside the school, that seem necessary to maintain the credit, usefulness and reputation of the school.





## ACTIVITIES AND FACILITIES

Learning becomes enjoyable and worthwhile when it is supplemented with activities, ideas and other stimulants. SPAB offers a host of such platforms to waken and to actualize the hidden talents and initiatives of its pupils. Activities include: Seminars, Projects, Workshops, Interactive Teaching, Field Trips, Excursions, Public Speaking, Dramatics, Music, Dance, Art & craft, Talent Search, Sports and games etc.

## EXTRA CURRICULAR & CO—CURRICULAR ACTIVITIES

Teaching does not need to be limited to text books and blackboards. With our fun school activities for kids, learning in school becomes an interesting and enjoyable exercise. Various clubs are introduced for skill development and to generate inquisitiveness, interest and encourage students to bring out creativity in them.

The ECA for Junior & Senior School are: Sports: Basket Ball, Cricket, Football, Skating, Badminton, Dance Contemporary Dance, Music- Keyboard, Guitar & Drums and also Karate & Abacus.







## FACILITIES INCLUDE

Well laid out courts for Football, facilities for Athletics, Volleyball, Basketball, Throw ball, Table Tennis, Cricket, Badminton, facilities for indoor games, well equipped Science Labs, spacious Computer Labs, well equipped Library, 32 Audio Visual Rooms, Activity Hall, Language Lab, Math Lab, Digital Class Rooms, Music Room, Art Room, Dance Room, Play Pen and an Auditorium.



# ADMISSIONS

The school management reserves to itself the right to admit or refuse pupils seeking admission to the School.

The pupils seeking admission should have completed on 31st May of same academic year; 3 years for Nursery, 4 years for LKG, 5 years for UKG and 6 years for Class I subsequently. Age proof must be accompanied by an attested Birth Certificate. Age once entered in the admission Register cannot be altered.

Pupils seeking admission to LKG and above may be tested on the syllabus of the class below the one to which they are seeking admission. Admission will be confirmed for the Classes II and above students only after the submission of the Original Transfer Certificate, Student Achievement Tracking System Number (SATS), and Permanent Education Number (PEN), issued by the UDISE +, from the school last attended .

Bonafide students from recognized schools may seek admission.

Admission cannot be claimed as a matter of right. Any attempt to use influence, unfair means, recommendations etc. will lead to automatic disqualification. The school does not have any agents for admission.

An Admission Number is issued to the pupil at the time of admission to the school. The Admission Number remains unchanged till the pupil leaves the school. Parents are requested to keep a record of the Admission Number and it has to be quoted for any official matters such as bonafide certificates, Transfer Certificates, Online Fee Payment, or any other official letters.





# FEE REGULATIONS

The school Fees are normally collected in three instalments

Ist Installment	on or before 10th of May
2nd Installment	on or before 10th of October
3rd Installment	on or before 10th of January

Transportation Fee is collected in two Installments

Ist Installment	on or before 25th of May
2nd Installment	on or before 10th of November

- School Fees can be collected in cash / Cheque/ DD
- A student joining or leaving school in the middle of the Academic Year will have to pay fee for the whole year
- Fees once paid will not be refunded in part or in full
- If the fee is paid after the stipulated date, a late fee of Rs.100/- Will be charged for each delayed week.



## WITHDRAWALS

A written requisition must be made for the issue of Transfer Certificates. The requisition must have the signature of both the parents/guardian.

Transfer certificates will be issued only when all the fees have been paid full. Full year's fees will be levied in case of admission / withdrawal in the middle of a term.

# Promotion Criteria & Incentives

Examinations are held at the end of each term. Continuous assessments of the students are carried on throughout the year. Class tests, Mid Terms, home assignments, project works etc. are marked.

A total of 40% marks in each subject on the average of the two terminal examinations are necessary for promotion.

As a policy, the school does not follow ranking system for any of the examinations; however, proficiency prize will be awarded to students after taking into consideration, the entire year's academic performance.



## Student Performance Analysis

Student Performance Analysis is used to determine the progress of the child on monthly, termly and annual basis. It is a unique tool to ensure self-discipline.





It is a positive approach towards making the students responsible for their deeds. This is aimed for providing transparency in selecting students for various awards. Students will be able to analyze his or her performance on a regular basis. Every activity of the student is taken into account: academic, co-curricular, behaviors, responsibilities, neatness etc....

## INCENTIVES

- Section-wise Proficiency Award will be presented on the basis of the student's performance in the Major Subjects and the student will also have to get 60% in the Enrichment Subjects i.e. Catechism/Value Education, General Knowledge and III Language.
- Proficiency prizes will not be awarded if a student misses any of the exams in part or in full.
- Prizes will be awarded to the students and staff who attain 100% attendance.



# SPECIAL ASSEMBLIES

Our students are provided a platform, to discover their potential and experience life through special assemblies. The topics are based on subjects, cultures, morality, religion, famous personalities, sports and other important /current Issues.

The special assemblies include Feast Day, Festivals, World Environment Day, Yoga Day, English Day, History Day, Hindi Day, National Mathematics Day, Computer Science Day, National Sports Day, Health Talks, Reading Day and many more. Important days like Independence Day, Children's Day, Teacher's Day, Republic Day, are also celebrated in the school in due manner.



# CLASS ASSEMBLIES

Class Assemblies are an initiative to bring out the hidden talent of our students. To give them ample amount of exposure and a chance to perform on stage, we have our class assemblies. It is a programme presented and designed by a specific class showcasing their talent under the guidance of their teachers. They perform numerous activities such as prayer, skit ,news reading thought for the day, dance, recitation, song, mime and character dramatization.



# COMPETITIONS

We expose our students to competitions to help them build confidence and promote a competitive spirit and to bring out the talents of the students. They are encouraged to participate in various competitions which are held in school.

By providing a conducive and encouraging environment the students are mentored to participate in a variety of interschool activities and competitions such as All India Talent Search Examination in Mathematics, Science, English, Cyber and Sports Quiz organized by Olympiad Foundation, Talent Search Exam conducted by KISA(Karnataka ICSE Schools Association), SpellBee competition conducted by SpellBee International, and IFSE'S English and Mathematics Examinations.

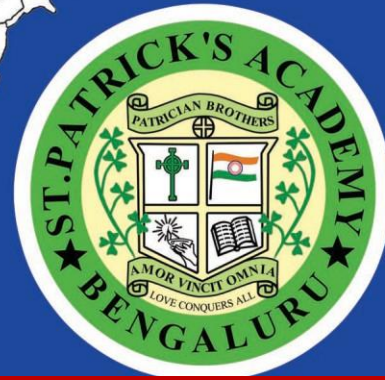
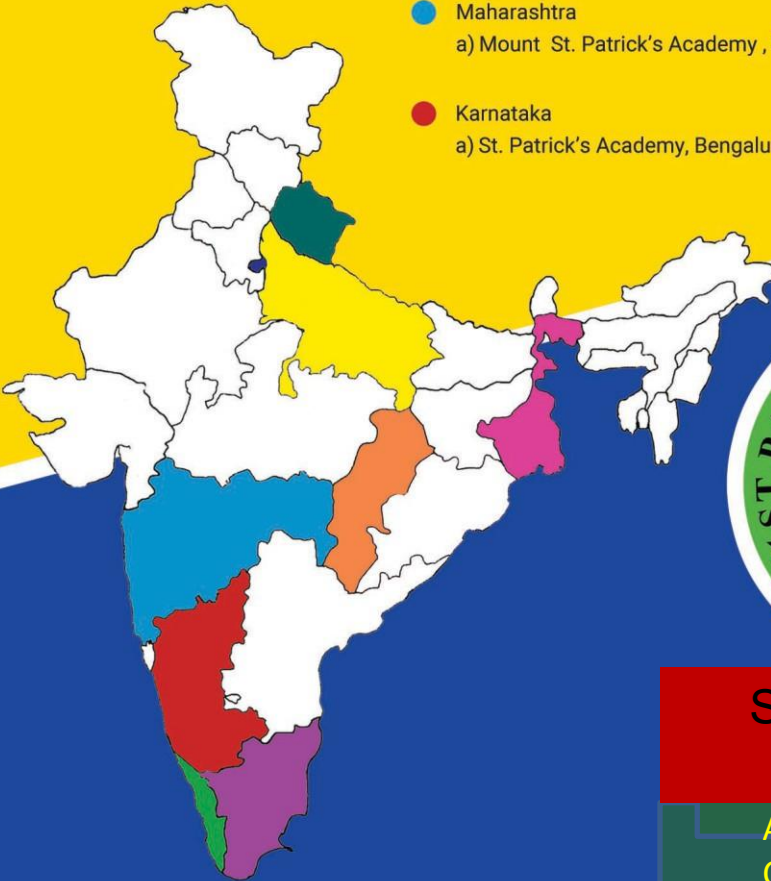
